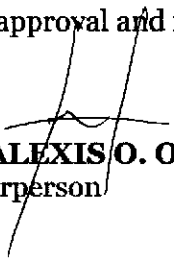

CHECKLIST OF ELIGIBILITY REQUIREMENTS	Recommendations
1. Certificate of Registration	For the sole proprietorship, Department of Trade and Industry (DTI) Registration and for the corporation Security and Exchange Commission (SEC) Registration with Articles of Incorporation.
2. Clearance from PNP SAGSD	If the bidder is from Regional area, the clearance will come from Regional Office and if the bidder is from Manila Area, the clearance will come from Central Office.
3. Certificate of Good Standing (SSS, Philhealth, and Pag-ibig) Latest Certificate of Good Standing issued from January until May 2019)	In lieu of non availability of the certificate, the bidder can provide letter request (SSS, Philhealth and Pag-ibig) with signed received from the agency. The certificate of good standing will be presented during post qualification of the winning bidder.
4. Clearance from Department of Labor and Employment (DOLE) (From NLRC, Regional and Local Offices)	Clearance will come from DOLE and NLRC. In lieu of non availability of the certificate, the bidder will provide letter request with signed received from the agency. The certificate of good standing will be presented during post qualification of the winning bidder.
5. Statement that the bidder is not "blacklisted" or banned from bidding by the government or any of its agencies, offices, corporation or LGU's and other private corporations or electric cooperatives; including non-inclusion in the Consolidated Blacklisting Report issued by the Government Procurement Policy Board (GPPB), as provided in Section 69.4 of the IRR-A No. 9184.	This will be included in the Omnibus Sworn Statement
6. Compliance with E.O. # 398 a. Proof of VAT payments for the past six months.	December 2018 to May 2019

b. Tax Clearance from the BIR to prove bidder's full and timely payment of taxes to the government. c. A Certification under oath from the bidder's responsible officers that the bidder is free and clear of all liabilities with the government.	Included in the Omnibus Sworn Statement
7. Statement in matrix from all ongoing and completed government and private contracts (service contracts, maintenance contracts, purchase orders, job orders, etc.) within the relevant period, where applicable, including contracts awarded but not yet started, if any. The statement shall state whether each contract is: a. Ongoing, Completed or Awarded but not yet started; within the relevant period, where applicable. Each contract should include the following: i. 9. Financial Documents	Year 2018 duly Audited by Bureau of Internal Revenue (BIR)
10. Net Financial Contracting Capacity (NFCC)	For the computation of NFCC, the multiplier is ten (10) percent.
11. Class "B" Documents: a. Valid Joint Venture Agreement	Please indicate Not Applicable (N/A) and state it in Omnibus Sworn Statement.
12. Computation for Approved Budget Cost; The Daily Wage is P 290.00	This should be Php 310.00
13. Bid Security	The accepted form of security is Cash or Manager's Check only.
14. SSS Premium	The SSS Premium should follow the April 2019 Adjusted computation.
15. Administrative fee	The computation for the Administrative fee should not be lower than the DOLE prescribed computation.
16. Omnibus Sworn Statement	The Omnibus Sworn Statement should include the following; a. [Name of Bidder] did not give or pay directly or indirectly, any commission, amount, fee, or any form of consideration, pecuniary or otherwise, to any person or official, personnel or

	representative of the government in relation to any procurement project or activity. The Omnibus Sworn Statement should be notarized. The Omnibus Sworn Statement should be present in the Legal and Financial Documents.
16. The mother/main envelopes	The mother/main envelopes should be sealed and with signature
17. All documents presents in all envelopes	All documents presents in all envelopes should be duly signed by authorized signatories.
